WHEREAS, a letter from the Office of the Municipal Mayor, dated October 20, 2022 has been received by the Office of the Sangguniang Bayan requesting for a resolution granting or authorizing the Local Chief Executive to enter and sign into a Memorandum Of Agreement (MOA) in behalf of the Municipal Government of Bulakan with Philippines Statistics Authority (PSA) for the implementation of *PhilSys Birth Registration Assistance Project* for the Municipality of Bulakan;

WHEREAS, the PSA created under Republic Act No. 10625 or the Philippine Statistical Act which took effect last 12th of September 2013 is mandated to collect, Compile and analyze, abstract and publish statistical information relating to the country’s economic, social, demographic, political affairs and general activities and condition of the people;

WHEREAS, the proposed project entitled “*PhilSys Birth Registration Assistance Project for the Municipality of Bulakan*” aims to increase civil registration in marginalized communities, particularly those belonging to the Indigenous People (IPs), Muslim Filipinos and the poorest sector;

WHEREAS, the Local Chief Executive upon authorization of the Sangguniang Bayan may represent the municipality in all of its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made pursuant to law and ordinance;
