## EXECUTIVE ORDER NO. 2022 - 34 Series of 2022

## AN ORDER CREATING THE TECHNICAL WORKING GROUP FOR THE FORMULATION OF THE MUNICIPAL TOURISM DEVELOPMENT PLAN OF THE MUNICIPALITY OF BULAKAN, BULACAN.

**WHEREAS**, the objective of the project is to formulate a Tourism Development Plan for Municipality of Bulakan for the next 5 years, to conduct financial projections (short, medium, and long term) in accordance with the appropriate business development plan to be established, and to identify immediate support on infrastructure necessary to the Tourism Development of the Municipality of Bulakan;

**WHEREAS,** there is a need to create a Technical Working Group (TWG) which shall ensure the performance of the above – mentioned project;

**WHEREAS**, the local government agencies, together with the private sectors, shall serve as the Technical Working Group to undertake and coordinate on the preparation, review, validation, approval and implementation of the Municipality of Bulakan Tourism Development Plan;

**NOW THEREFORE, I, VERGEL C. MENESES**, Municipal Mayor of the Municipality of Bulakan, by virtue of the power vested in me by the law, do hereby order the following:

**SECTION 1. CREATION.** There is hereby created a Technical Working Group (TWG) to assist in the creation of the Municipal Tourism Development Plan of the Municipality of Bulakan.

**SECTION 2. COMPOSITION OF THE TECHNICAL WORKING GROUP (TWG).** The Technical Working Group (TWG) shall be composed of the following:

**SECTION 3. ROLES AND RESPOSIBILITIES OF THE TWG.** The TWG is responsible for the preparation, review, finalization, legitimization, and approval of the Bulakan Tourism Development Plan following good governance principles of transparency, accountability, and participatory decision—making.

**SECTION 4. LEAD OFFICE AND SECRETARIAT OF THE TWG.** The Municipality of Bulakan Tourism Operation Office (MBTOO), in close coordination with other local and regional government offices and private stakeholders under Tourism Industry, shall serve as the lead office responsible for the completion and legitimization of the Bulakan TDP. The MBTOO shall also as the overall secretariat of the TWG.

**SECTION 5. TERM**. The Technical Working Group shall exist until it has accomplished the purpose of this Order.

**SECTION 6. SEPERABILITY CLAUSE.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 7. REPEALING CLAUSE**. All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 8. EFFECTIVITY.** This executive order shall take effect immediately.
