AN ORDER RECONSTITUTING THE MUNICIPAL FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCIL (MFARMC) IN THE MUNICIPALITY OF BULAKAN.

WHEREAS, pursuant to Municipal Ordinance No. 07-142 also known as Fishery Code of 2007, the municipality needs to institutionalize a council to supervise all activities in its municipal waters;

WHEREAS, Local Government Unit requires to establish the Municipal Fisheries and Aquatic Resources Management Council (MFARMC), an accountable, efficient and dynamic team to provide plans and programs and other duties and functions provided pursuant to laws and ordinances;

WHEREAS, Section 465, par. (b) of the Local Government Code, the Municipal Mayor, as the chief executive of the municipal government, is authorized to adopt such emergency measures as may be necessary during and in the aftermath of manmade and natural and natural disaster and calamities, issue such executive order for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, VERGEL C. MENESES, Municipal Mayor of Bulakan, Bulacan by virtue of the powers vested in me by the law do hereby order the following:

SECTION 1. Creation. There is hereby constitute the Municipal Fisheries and Aquatic Resources Management Council (MFARMC) for the Municipal Government of Bulakan.

SECTION 2. Composition. The Municipal Fisheries and Aquatic Resources Management Council (MFARMC) shall be composed of the following:

SECTION 3. Functions. The MFARMC shall exercise the following functions:

- Assist in the preparation of the Municipal Fishery Development Plan and submit such plan to the Municipal Development Council.
- Recommend the enactment of the Municipal Fishery Ordinance to the Sangguniang Bayan through its committee on fisheries
- Assist in the enforcement of fishery laws, rules and regulations in the municipal waters.
- Advice the Sangguniang Bayan in Fishery matters through its committee on fisheries, if such has been organized; and
- Perform such other functions which may be assigned.

SECTION 4. Effectivity. This Order shall take effect immediately.
