**AN ORDER REORGANIZING THE MUNICIPAL DISASTER RISK
REDUCTION AND MANAGEMENT COUNCIL (MDRRMC).**

WHEREAS, Republic Act No. 10121 also known as "**Philippine Disaster Risk Reduction and Management Act**" which will help develop, promote and implement a Comprehensive National Disaster Risk Reduction and Management Plan that aims to strengthen the capacity of the national government and the local government units (LGUs) together with partners stakeholders, to build the Disaster resilience of Community, and to institutionalize arrangements and measures to reducing disaster risk including projected climate risks and enhancing disaster preparedness and response capabilities at all levels, there is hereby created the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of Bulakan, Bulacan;

WHEREAS, this Republic Act No. 10121 recognize local risk patterns across the country and direct the strengthening of local government capacities on disaster risk reduction and management through decentralize powers, responsibilities and resources;

WHEREAS, pursuant to section 324 of Local government Code of 1991, as amended by Republic Act No. 8185, stated the Local Government units shall adopt measures to protect its inhabitants from harmful effects of man – made or natural calamities and to provide relief services and assistance victims during and in their return to productive livelihood.

NOW, THEREFORE, I, VERGEL C. MENESES, Municipal Mayor of Bulakan, Province of Bulacan, by virtue of the powers vested in me by law do hereby reorganize the Municipal Disaster Risk Reduction and management Council (MDRRMC), the composition with the following provisions, to wit:

SECTION 1. Composition of Municipal Disaster Risk Reduction and Management Council. - The Municipal Disaster Risk Reduction and Management Council (MDRRMC) shall be composed of the following:

SECTION 2. Functions, Duties And Responsibilities Of The Municipal Disaster Risk Reduction Management Council (MDRRMC) Shall Carry Out, Observe, Fulfil The Following Functions:

1. Approve, monitor and evaluate the implementation of the Municipal Disaster Risk Reduction Management Council (MDRRMC) plans and regularly review, test and develop the plan consistent with other National and Local Planning Programs;
2. Ensure the integration of disaster risk reduction and climate change adaptation into Municipal Development Plans, Programs and budgets as a strategy in sustainable development and poverty reduction;
3. Recommend the implementation of forced or pre-emptive evacuation of local residences, if necessary,
4. Convene every Three Months, last Friday, 2:00 in the afternoon or as often as necessary to effectively coordinate the effects on disaster mitigation, preparedness, response, emergency operations and rehabilitation activities;
5. Call on other department, bureaus, agencies, instrumentalities and corporations of the government and the private sector for assistance in preparing for, reacting to and receiving from the effects of disaster and civil emergencies.
6. Advise the Barangay Disaster Risk Reduction and Management Committee regarding Disaster management.
7. All members of the council shall make available their personnel, facilities and expertise to effectively carry out the functions of the council.
8. The Council shall discharge such other functions and duties which is necessary and directly related to its mandate, in consonance with the provision of RA. No.10121 and its implementing Rules and Regulations.

SECTION 3. Municipal Disaster Risk Reduction And Management Office And Functions - There is hereby created a Municipal Disaster Risk Reduction and Management Office under the Office of the Municipal Mayor and situated at Bulakan Evacuation Center which shall discharge, perform and observe the following functions:

1. Design, program and coordinate disaster risk reduction and management activities consistent the national council standards and guidelines;
2. Facilitate and support risk assessment and contingency planning activities at the Municipal Level;
3. Consolidate local disaster risk information which includes natural hazards, vulnerabilities and climate change risks, and maintain a local risk map;
4. Organize and conduct training orientation and knowledge management activities on disaster risk reduction management at the Municipal and Barangay level.
5. To provide and disseminate early warning system with accurate and timely advice to response local emergency with the Municipality.
6. Formulate and implement comprehensive and integrated Municipal Disaster Risk Reduction Plan in with the coordination with the Municipal the Development Council (MDC)
7. Identify, assess and manage the hazards vulnerabilities and risk that may occur and implement cost. Effective reduction measures and strategies.
8. Strengthening and operational partnership with private sectors, CSOs and volunteer group.

9. Serve as the Secretariat and Executive arm of the Municipal Disaster Risk Reduction and Management Council (MDRRMC)

SECTION 4. EFFECTIVITY - This Executive Order shall take effect after signing.
