**WHEREAS**, a letter from the Office of the Municipal Mayor, dated October 20, 2022 has been received by the Office of the Sangguniang Bayan requesting for a resolution granting or authorizing the Local Chief Executive to enter and sign into Memorandum Of Agreement (MOA) in behalf of the Municipal Government of Bulakan with Department of Health – Central Luzon Center for Health Development for the distribution of ONE COVID-19 Allowance (OCA) for public and private health care workers and non-health care workers;

**WHEREAS**, the Republic Act (RA) No. 11639, or the General Appropriations Act (GAA) for Fiscal Year 2022, provides the basis for funds release on the grant of COVID-19 benefits for public and private health workers and non-health care workers regardless of employment status, who are involved in COVID-19 response in all health facilities including military hospitals, Government-Owned and Controlled Corporations (GOCCs), State University Hospitals and private-licensed health facilities;

**WHEREAS**, the Department of Budget and Management (DBM) and DOH issued Joint Circular (JC) No. 2022-0001, dated February 10, 2022, providing the guidelines for the grant of ONE COVID-19 ALLOWANCE (OCA) for the Public and Private health care workers and non-health care workers particularly requiring the parties to enter into a Memorandum of Agreement;

**WHEREAS**, a Memorandum of Agreement is executed were terms and conditions stipulated upon to be acknowledge by the Parties for proper implementation of said program;

**WHEREAS**, the Local Chief Executive upon authorization of the Sangguniang Bayan may represent the municipality in all of its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made pursuant to law and ordinance;

**NOW THEREFORE**, for and in consideration of the above-mentioned premises and upon motion of Hon. Atty. Ana Marie V. Pagsibigan and duly seconded and unanimously approved by all members present in session assembled;

**RESOLVED**, as it is hereby resolved to approve this Resolution Authorizing Hon. Vergel C. Meneses, Municipal Mayor, To Enter And Sign Into A Memorandum Of Agreement (MOA) In Behalf Of The Municipal Government Of Bulakan With Department Of Health – Central Luzon Center For Health Development For The Distribution Of ONE COVID-19 ALLOWANCE (OCA) For Public And Private Health Care Workers And Non-Health Care Workers”


