EXECUTIVE ORDER NO. 2022 - 10 Series of 2022

AN ORDER CREATING MUNICIPAL PUBLIC FINANCIAL MANAGEMENT TEAM TO SPEARHEAD IN THE IMPLEMENTATION OF PUBLIC FINANCIAL MANAGEMENT TOOL FOR THE MUNICIPALITY OF BULAKAN, BULACAN.

WHEREAS, pursuant to Department of Budget and Management – Local Budget Circular No. 101 dated Oct. 12 2013 to prescribe the use of the Public Financial Management Assessment Tool for Local Government Units (PFMAT for LGUs as a means of institutionalizing governance reforms through timely PFM assessment and PFM improvement planning exercises;

WHEREAS, PFMAT for LGUs support the operative principle of decentralization set forth under Section 3(b) of the 1991 Local Government Code, which requires the establishment in every local government unit of an accountable, efficient and dynamic organizational structure and operating mechanism that will meet the priority needs and service requirements of its communities;

WHEREAS, PFMAT for LGUs is a self-assessment, evidence-based instruments which describes the characteristics of an open and orderly PFM System that will help the LGUs identify the strengths and weaknesses as basis for improvement measures;

NOW THEREFORE, I, VERGEL C. MENESES, Municipal Mayor of Bulakan by virtue of the powers vested in me by law do hereby order the following:

Section 1. Creation. There is hereby created in the Municipality of Bulakan the Local Public Financial Management Team or PFMAT.

Section 2. Composition. The Local Public Financial Management Team shall be composed of the following:

Section 3 Functions. The following are the functions of Local Public Financial Management Team:

- To ensure the widest application of the PFMAT for LGUs;
- To attend orientation-workshops to be conducted by DBM Regional Offices relative to implementation of Public Financial Management Assessment Tool for Local Government Units;
- Identify the strengths and weaknesses in the PFM System as basis for improvement measures;
- d. To apply PFMAT in the LGU and recommend measures to the Local Chief Executive and to the Sanggunian Bayan to improve financial management system in the LGU;

Section 4. Effectivity. This Executive Order shall take effect after signing.
