## EXECUTIVE ORDER NO. 2022-42 Series of 2022

## AN ORDER RECOGNIZING THE UPDATED INVENTORY OF BULAKAN'S CULTURAL PROPERTIES FOR 2022 IN THE MUNICIPALITY OF BULAKAN.

**WHEREAS**, Section 12, Article XIV of the 1987 Philippine Constitution provides that the State shall conserve, promote and popularize the nation's historical and cultural heritage and resources, as well as artistic creations;

**WHEREAS,** it is the policy of the State to preserve and protect important cultural properties and national cultural treasures of the nation and safeguard their intrinsic value;

**WHEREAS,** the country's artistic and historic wealth constitutes cultural treasures of the nation and shall be under the protection of the State;

**WHEREAS,** Republic Act No. 10066 otherwise known as The National Cultural Heritage Act of 2009 mandates the local government units through their cultural offices to maintain an inventory of cultural properties under its jurisdiction and shall furnish the National Commission for Culture and the Arts (NCCA) a copy of the same;

**WHEREAS,** the Department of Interior and Local Government (DILG) and the NCCA issued Joint Memorandum Circular No. 2018-01, otherwise known as the Local Inventory of Cultural Property as required under Republic Act No. 10066 enjoin local chief executives to maintain a local inventory of all cultural property within their jurisdiction;

**WHEREAS,** the NCCA had issued Board Resolution No. 2017-330 entitled Guidelines Governing the Philippine Registry of Cultural Property (PRECUP) requiring local cultural database to be accompanied by an ordinance recognizing it as the local inventory;

**WHEREAS,** the Bulakan Tourism Office as of December 2022 had created and prepared a list of identified tangible heritage and cultural properties;

**NOW THEREFORE, I, VERGEL C. MENESES, Municipal Mayor of Bulakan**, by virtue of power vested in me by law hereby recognizes the official updated list of Cultural Properties in Bulakan as prepared by Bulakan Tourism Office with the following provisions:

**SECTION 1. LIST OF CULTURAL PROPERTIES.** Tangible Immovable Cultural Properties. Those are man – made structures in Bulakan, such as but not limited to, bridges, government buildings, houses of ancestry, traditional dwellings, quartels, train stations, lighthouses, small ports, educational, technological, and industrial complexes and their settings, and landscape with the notable historical, archival, anthropological, archeological, artistic, and architectural value. The following are tangible immovable properties of Bulakan:

**SECTION 2. UPDATING OF DATABASE.** The Bulakan Tourism Office shall continuously update the information and data collected concerning cultural properties.

**SECTION 3. REPEALING CLAUSE.** All orders, rules regulations and issuances, or parts, thereof, which are inconsistent with this Order, are hereby repealed, amended, or modified accordingly.

**SECTION 4. SEPERABILITY CLAUSE.** If for any reason, any provision of this Order is declared unconstitutional or invalid, the remaining provisions not affected thereby shall continue to be in full legal force and effect.

**SECTION 5. EFFECTIVITY CLAUSE.** This Order shall take effect immediately.
