EXECUTIVE ORDER NO. 2022 – 07 Series of 2022

AN ORDER REORGANIZING THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC).

WHEREAS, pursuant to Memorandum Circular No. 91-57 and Article 104 and 105 of the Child Youth Welfare Code, that there shall be created every Municipality a Local Council For The Protection of Children for the purpose of further enduring the effective implementation for the Child Youth Welfare Code;

WHEREAS, pursuant to Section 444 (2) (iii) of the Local Government Code of 1991, the Municipal Mayor, as the chief executive of the municipal government, is authorized to adopt and issue an executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW, THEREFORE, I, VERGEL C. MENESES, Municipal Mayor of Bulakan, Province of Bulacan by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local Council for the Protection of Children (LCPC) with the following provisions:

SECTION 1. Composition of the Local Council for the Protection of Children. –

The Local Council for the Protection of Children is hereby reorganized to be composed and represented as follows:

SECTION 2. Functions and Responsibilities.- The LCPC shall perform the following functions and responsibilities:

- a. Formulate Municipal Plan of Action for Children, incorporating projects and programs needing assistance by the Barangay and ensure its integration into the Municipal Development Plan.
- b. Monitor and evaluate the implementation of the Municipal Plan.
- c. Submit quarterly status report on the plan implementation the PCWC through the Municipal Planning and Development Office.
- d. Promptly address issues and concerns affecting children and youth.
- e. Advocate for the increased support and resource allocation for the children's programs and projects.
- f. Provide technical assistance to the community based frontline workers through conduct of capability building and human resources development activities.
- g. Prepare contingency measures to protect children and their families in crisis situation brought about by the natural and man-made calamities.


SECTION 3. The Secretariat. - Secretariat support shall be logged with the Municipal Social Welfare Officer Staff who shall be responsible for the documentation of proceeding of meetings and preparation reports and other necessary documents as needed by the committee.

SECTION 4. SEPARABILITY CLAUSE -If any part or provision of this Executive Order is held invalid or unconstitutional by any competent court, the other parts or provisions not affected shall remain valid.

SECTION 5. REPEALING CLAUSE - All ordinances, rules, regulations and other issuances or parts thereof that are inconsistent with its Executive Order are hereby replaced or modified accordingly.

SECTION 6. EFFECTIVITY - This Executive Order shall take effect immediately upon signing.
