### EXECUTIVE ORDER NO. 2022 - 08 Series of 2022

#### AN ORDER REORGANIZING THE MUNICIPAL EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COORDINATING COMMITTEE.

**WHEREAS**, in pursuant to Republic Act 8960, an act promulgating a comprehensive policy and a national system for Early Childhood Care and Development (ECCD) in which each Municipality shall adopt for purposes and its objective;

**WHEREAS**, the Municipality shall promote the rights of children to survival, development and special protection with full recognition of the nature of childhood and its special needs and to support parents in their roles as primary caregivers;

**WHEREAS**, pursuant to Section 444 (2) (iii) of the Local Government Code of 1991, the Municipal Mayor, as the chief executive of the municipal government, is authorized to adopt and issue an executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

**NOW, THEREFORE, I, VERGEL C. MENESES**, Municipal Mayor of Bulacan, Province of Bulacan by virtue of the powers vested in me by law, do hereby order the reconstitution of the Municipal Early Childhood Care And Development (ECCD) Coordinating Committee with the following provisions:

**SECTION 1. COMPOSITION OF THE MUNICIPAL EARLY CHILDHOOD CARE DEVELOPMENT COORDINATING COMMITTEE** – The Municipal Early Childhood Care Development Coordinating Committee is hereby reorganized to be composed of the incumbent officers or officials of the following:

**SECTION 2. THE ECCD FUNCTIONS AND RESPONSIBILITIES.** - The Municipal Early Childhood Care Development Coordinating Committee (ECCD) shall perform the following functions and responsibility:

1. The Municipal ECCD Coordinating Committee shall be under the Municipal Development Council and shall perform similar functions as the council as appropriate, including other functions that may be provided in the implementing rules and regulations.
2. It shall likewise support and complement the resources available to Barangay in the expansion and improvement of ECCD programs.
3. Coordinate and monitor the delivery of services at the Barangay level.
4. Ensure accurate reporting and documentation of service delivery, as well as mobilized and encourage private sector initiatives for the establishment of ECCD program implementation in the Municipality that conforms to National ECCD System standards.

**SECTION 3. SECRETARIAT** – The Municipal ECCD Coordinating Committee shall organized a Secretariat which shall coordinate and monitor the effective implementation of ECCD program in the Municipality. It shall be headed by the Municipal ECCD officer, who shall be appointed by the Mayor, upon the recommendation of the Municipal ECCD Coordinating Committee.

**SECTION 6. EFFECTIVITY** - This Executive Order shall take effect immediately upon signing.
