## EXECUTIVE ORDER NO.8

REORGANIZATION OF THE LOCAL MANILA BAY CLEAN UP, REHABILITATION AND PRESERVATION PROJECT (MBCURPP) INSPECTION, INVENTORY AND MONITORING TEAM (IIMT)

WHEREAS, in compliance with the Supreme Court En Banc Decision dated December 18, 2008 and En Banc Resolution dated February 15, 2011, all Provincial Governors and concerned Mayors of Cities and Municipalities within the Manila Bay area are directed to organize the Local Manila Bay Clean Up, Rehabilitation and Preservation Project Inspection, Inventory and Monitoring Team.

**NOW, THEREFORE, I VERGEL C. MENESES,** Municipal Mayor of the Municipality of Bulakan, by the virtue of the power Vested in me by law do hereby reorganize the Local Manila Bay Clean up, Rehabilitation reservation Project Inspection, Inventory and Monitoring Team (MBCURPP-IIMT).

SECTION I. COMPOSITION- The Local Manila Bay Clean Up, Rehabilitation and Preservation Project Inspection, Inventory Monitoring Team

SECTION II. DUTIES AND RESPONSIBILITIES-The local MMBCURPPIIMT shall have the following duties and responsibilities:

- Conduct Inspection and Inventory of all factories, commercial establishments and private homes within the Municipality.
- Monitor the compliance of non- complying factories, commercial establishments and private homes within the Municipality.
- Recommend the Imposition of necessary sanctions and penalties to the Local Chief Executive of all non-complying factories, commercial establishments and private homes within the Municipality.
- 4. Prepare and submit the following report once every quarter
  - Quarterly Key Performance Indicators (KPI) compliance.
  - MBCURP Form I-Inventory and Inspection of Commercial Establishment, Factories and Private Homes with Septic Tanks and Waste Water Treatment Facilities
  - MBCURP Form 2.1- Solid Waste Management (for cities and Municipalities
  - MBCURP Form 2.2- Solid Waste Management (for Barangays)
  - MBCURP Form 3- Informal Settler Families
  - MBCURP Form 4- Information Education Campaign
  - MBCURP Form 5- Associated Report (Ordinances and Status of Implementation)

Initial Report shall be submitted not later than the end of October 2019 while succeeding reports shall be submitted every 5<sup>th</sup> day of the ensuing month offer the end of the quarter.

Perform other task as may be assigned from time to time relative to the Implementation of the Manila Bay Clean -Up, Rehabilitation and Preservation Project.

SECTION III. COORDINATING INSTRUCTION- The Municipal Local Government Officer of the DILG shall act as Secretariat and provide the necessary technical assistance and monitor the compliance of this issuance.

SECTION IV. EFFECTIVITY-This Executive Order shall take effect immediately.
