MENESES, MUNICIPAL MAYOR, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPAL GOVERNMENT OF BULAKAN WITH REGIONAL DIRECTOR JULIUS CAESAR V. SICAT PhD., CESO III IN BEHALF OF THE DEPARTMENT OF SCIENCE AND TECHNOLOGY REGION III FOR THE DONATION OF ONE (1) UNSINKABLE SMALL WATERCRAFT TECHNOLOGY UNDER THE CEST PROGRAM.

WHEREAS, letter from the Office of the Municipal Mayor dated July 22, 2022 has been received by the Office of the Sangguniang Bayan requesting for a resolution granting or authorizing the Local Chief Executive to enter and sign into a Memorandum of Agreement with the Department Of Science And Technology (DOST), RE: Donation of One (1) Unsikable Small Watercraft Technology under CEST Program.

WHEREAS, the local government have the mandate based on the (c), Section 22, Chapter 2 of Local Government Code of 1991 "unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned..."

WHEREAS, the DOST is a government agency mandated by law to implement the law/ rules/ regulations/ policies/ plans/ programs/ projects in the region as well as to provide efficient S&T Services and coordinate with local government units on S&T matters in the region;

WHEREAS, the Community Empowerment through Science and Technology (CEST) Program aims to empower marginalized and geographically isolated and disadvantaged communities in Central Luzon as the priority groups to be assisted by the program through the holistic approach of its five entry points with due respect to beliefs, customs traditions and institutions;

WHEREAS, DOST III promotes and implements disaster risk reduction and management and climate change adaptation-related projects as part of the CEST program and recognizes the benefits of working together with government agencies in the implementation of its Disaster Risk Reduction and Management and Climate Change Adaptation (DRMM & CCA) projects in the region;

WHEREAS, DOST III has also partnered with local inventors in the adoption of locally developed technologies and innovations such as the Unsinkable Small Watercraft for the improvement of disaster response of local government units in mitigating the challenges encountered during and after calamities and disasters, especially during flooding;

WHEREAS, the Municipality of Bulakan is interested in commitment to assist DOST III in its objective to implement the project Strengthening the Disaster Rescue and Relief Capabilities of Poor and Vulnerable Communities through Adoption of Locally Develop DRRM Technologies and achieve the project target deliverables including the project target impacts;

WHEREAS, a Memorandum of Agreement is executed were terms and conditions stipulated upon to be acknowledge by the Parties for proper implementation of said program;

WHEREAS, the Local Chief Executive upon authorization of the Sangguniang Bayan may represent the municipality in all of its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made pursuant to law and ordinance;

NOW THEREFORE, for and in consideration of the above-mentioned premises and upon motion of Hon. Atty. Ana Marie V. Pagsibigan and duly seconded and unanimously approved by all members present in session assembled;

RESOLVED, as it is hereby resolved to approve this Resolution Authorizing Hon. Vergel C. Meneses, Municipal Mayor, To Enter And Sign Into A Memorandum Of Agreement (Moa) In Behalf Of The Municipal Government Of Bulakan With Regional Director Julius Caesar V. Sicat Phd., Ceso Iii In Behalf Of The Department Of Science And Technology Region Iii For The Donation Of One (1) Unsinkable Small Watercraft Technology Under The Cest Program.
