**ADOPTION OF MUNICIPAL EARLY CHILDHOOD CARE
DEVELOPMENT COORDINATING COMMITTEE**

WHEREAS, in pursuant to Republic Act 8960, an act promulgating a comprehensive policy and a national system for Early Childhood Care and Development (ECCD) in which each Municipality shall adopt for purposes and its objective.

WHEREAS, the Municipality shall promote the rights of children to survival, development and special protection with full recognition of the nature of childhood and its special needs and to support parents in their roles as primary caregivers.

WHEREAS, the Municipal Early Childhood Care Development Coordinating Committee (ECCD) shall perform the following functions and responsibility.

1. The Municipal ECCD Coordinating Committee shall be under the Municipal Development Council and shall perform similar functions as the council as appropriate, including other functions that may be provided in the implementing rules and regulations.
2. It shall likewise support and complement the resources available to Barangay in the expansion and improvement of ECCD programs.,
3. Coordinate and monitor the delivery of services at the Barangay level.
4. Ensure accurate reporting and documentation of service delivery, as well as mobilized and encourage private sector initiatives for the establishment of ECCD program implementation in the Municipality that conforms to National ECCD System standards.





SECRETARIAT- the Municipal ECCD Coordinating Committee shall organized a Secretariat which shall coordinate and monitor the effective implementation of ECCD program in the Municipality. If shall be headed by the Municipal ECCD officer, who shall be appointed by the Mayor, upon the recommendation of the Municipal ECCD Coordinating Committee.
