**EXECUTIVE ORDER No. 2022 - 14**  
Series of 2022

**AN ORDER CONSTITUTING THE MUNICIPAL SOLID  
WASTE MANAGEMENT BOARD.**

**WHEREAS**, the increasing volume of garbage is posing a serious threat to the general welfare and health of the people, as well as, to the integrity of the environment;

**WHEREAS**, in order to protect the environment and patrimony of future generation of Filipino, the government should work hand in hand with private sector in achieving a zero waste free society;

**WHEREAS**, Republic Act No. 9003, Chapter II, Section 10, states the role of the government, pursuant to the relevant provisions of RA No. 7160, otherwise known as the local government code, the LGU shall be primarily responsible for the implementation and enforcement of the provisions of this Act within their respective jurisdictions;

**WHEREAS**, it is also states that segregation and collection of solid waste shall be conducted at the Barangay level specifically for biodegradable, compostable and reusable waste; Provided, that the collection of non-recyclable, materials and special wastes shall be the responsibility of the municipality;

**WHEREAS**, Republic Act 9003, Article 4, Section 32 states that there shall be established a Material Recovery Facilities (MRF) in every Barangay or Cluster of Barangay;

**WHEREAS**, Republic Act 9003 enjoins all Municipalities to create the Municipal Solid Waste Management Board;

**NOW THEREFORE, I, VERGEL C. MENESES**, by virtue of powers vested in me as Municipal Mayor of the Municipality of Bulakan, do hereby order to reconstitute the Municipal Solid Waste Management Board, to wit:

**SECTION 1. COMPOSITION** - The Municipal Solid Waste Management Board shall be composing of the following:

**SECTION 2. DUTIES AND RESPONSIBILITIES** - The Municipal Solid Waste Management Board shall have the following duties and responsibilities:

1. Develop Municipal Solid Waste Management Plan that shall ensure the long-term management of Solid Waste, as well as integrate the various Solid waste Management Plan, it shall conduct consultation with the various sectors of the community;
2. Adopt measure to promote and ensure the viability and effective implementation of solid waste management programs in its component barangays;
3. Monitor the implementation of the Municipal Solid Waste Management Plan through it various political subdivisions and in cooperation with the private sector and the NGO's;
4. Adopt specific revenue-generating measures to promote the viability of its solid waste management plan;

5. Convene regular meetings for purposes of planning and coordinating the implementation of the solid waste management plans of the respective component barangays;
6. Oversee the implementation of the Municipal Solid Waste Management Plan;
7. Review every two(2) years or as the need arises the Municipal Solid Waste Management Plan for purposes of ensuring its sustainability, viability, effectiveness and relevance in relation to local and international development in the field of solid waste management;
8. Develop the specific mechanics and guidelines for the implementation of the Municipal Solid Waste Management Plan;
9. Recommend to appropriate local government authorities specific measures or proposals for franchise or built-operate transfer agreements with duly recognized institutions, pursuant to RA. 6957, to provide either exclusive or non-exclusive authority for the collection, transfer, storage, processing, recycling or disposal of Municipal Solid Waste. The proposals shall take into consideration appropriate government rules and regulations on contracts, franchise and built, operate-transfer agreement;
10. Provide the necessary logistical and operational support to its component Municipalities in consonance with sub section (1) of section 17 Of the Local government code.
11. Recommend measures and safeguards against pollution and for the preservation of the natural ecosystem ; and
12. Coordinates the efforts of its component barangays in the implementation of the Municipal Solid Waste Management Plan.

**Section 3. EFFECTIVITY.** This Executive Order shall take effect after signing and shall remain in effect until revoked.
