**REORGANIZATION OF THE LOCAL MANILA BAY CLEAN-UP,
REHABILITATION AND PRESERVATION PROJECT (MBCURPP) INSPECTION,
INVENTORY AND MONITORING TEAM (IIMT) OF THE MUNICIPALITY
OF BULAKAN.**

WHEREAS, in compliance with the Supreme Court En Decision dated December 18, 2008 and En Banc Resolution dated February 15, 2011, all provincial Governor and concerned Mayor of Cities and Municipalities within the Manila Bay area are directed to organize the Local Manila Bay Clean Up, Rehabilitation and Preservation Project Inspection, Inventory and Monitoring Team.

NOW, THEREFORE, I, VERGEL C. MENESES, Municipal Mayors of the municipality of Bulakan, by the virtue of the power vested in me by law do hereby reorganize the Local Manila Bay Clean up, Rehabilitation Reservation Project Inspection, Inventory and Monitoring Team (MBCURPP-IIMT).

SECTION I. COMPOSITION - The Local Manila Bay Clean up, Rehabilitation and Prevention Project Inspection, Inventory Monitoring Team (MBCURPP-IIMT) shall be composed of the following to wit:

SECTION II. DUTIES AND RESPONSIBILITIES - The Local MBCURPP-IIMT shall have following duties and responsibilities:

1. Conduct Inspection and Inventory and responsibilities.
2. Monitor the compliance of non-complying factories, commercial establishment and private homes within the municipality.
3. Recommend the Imposition of necessary sanctions and penalties to the Local Chief Executive of all non-complying factories, commercial establishment and private homes within the Municipality.
4. Prepare and submit the following report once every quarter
 - Quarterly Key Performance indicators (KPI) compliance
 - MBCURPP Form I-Inventory and Inspection of Commercial Establishment, Factories and private Homes with Septic Tanks and Waste Water Treatment Facilities
 - MBCURPP Form 2.1 - Solid waste Management (for cities and Municipalities)
 - MBCURPP Form 2.2 Solid Waste Management (for barangays)
 - MBCURPP Form Information Education Campaign
 - MBCURPP Form 5 - Associated Report (Ordinances and status of Implementation)

Initial Report shall be submitted not later than the end of October in issuing year while succeeding reports shall be submitted every 5th day of the ensuing month after the end of the quarter.

5. Perform other task as may be assigned from time to time relative to the implementation of the Manila Bay Clean - Up, Rehabilitation and Preservation Project.

SECTION III. COORDINATING INSTRUCTION - The Municipal Local Government Operation Officer of the DILG shall act as Secretariat and provide the necessary technical assistance and monitor the compliance of this issuance.

SECTION IV. EFFECTIVELY - This Order shall take effect immediately.
