## AN ORDER RE-ORGANIZING THE MEMBERS OF THE BIDS AND AWARDS COMMITTEE (BAC), HEAD'S BAC SECRETARIAT AND TECHNICAL WORKING GROUP FOR THE MUNICIPALITY OF BULAKAN, FOR THE CALENDAR YEAR 2022.

**WHEREAS**, it is a declared policy of the Municipality of Bulakan to promote the ideals of good governance and transparency in the procurement process and in the implementation of procurement contracts;

**WHEREAS**, Section 11 of R.A. 9184 provides that each procuring entity shall establish a Bids and Awards Committee (BAC) to undertake the functions specified in Section 12 of R.A 9184;

**WHEREAS**, Section 11.2.1 and 11.2.6 of the Revised IRR of R.A 9184 provides that the Head of the Procuring Entity shall designate the members of the BAC with a fixed term of one (1) year reckoned from the date of designation;

**WHEREAS**, Section 14 of the Revised IRR of R.A. 9184 provides that the Head of the Procuring Entity shall create a Secretariat which will served as the main support unit of the BAC and shall have the functions and responsibilities as provided for in Section 14.1;

**WHEREAS**, with the end of the term of the previous appointing authority and with a new administration taking over as head of the Procuring Entity, there is a need to reorganized the Bids and Awards Committee;

**NOW THEREFORE, I, VERGEL C. MENESES**, as the Municipal Mayor of Bulakan, Bulacan, by virtue of the powers vested in me by law, do hereby order the Re-Organization of of the Bids and Awards Committee, to wit:

**SECTION 1. BAC COMPOSITION.** The Bids and Awards Committee and the Head of the BAC Secretariat of the Municipal Government of Bulakan for the calendar year 2020 shall be composed of the following effective July 1, 2022:
