DIRAIN IN BEHALF OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE III (DSWD-FO III) FOR THE CONTINUED IMPLEMENTATION OF PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) ACT FOR THE MUNICIPALITY OF BULAKAN"

WHEREAS, letter from the Office of the Municipal Mayor dated September 8, 2022 has been received by the Office of the Sangguniang Bayan requesting for a resolution granting or authorizing the Local Chief Executive to enter and sign into a General Memorandum of Agreement with the Department of Social Welfare And Development – Field Office III (DSWD-FO III) for the continued implementation of *Pantawid Pamilyang Pilipino Program (4ps) Act* for the Municipality of Bulakan;

WHEREAS, the local government have the mandate based on the (c), Section 22, Chapter 2 of Local Government Code of 1991 "unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned..."

WHEREAS, the Department of Social Welfare and Development (DSWD) is a government agency that recognizes the valuable role, participation and engagement of LGUs as they lawfully exercise their powers necessary for the delivery of programs and services for the general welfare;

WHEREAS, the Municipality of Bulakan is as Local Government Unit has the following capacity and powers to grant the needed programs and services among others are:

- Social welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons, community based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents and victims of drug abuse, livelihood and other pro-poor projects, nutrition services and family planning services;
- Health Services which include the implementation of programs and projects on primary control services, access to secondary and tertiary health services, purchase of medicines, medical supplies and equipment needed to carry out the services herein enumerated:
- Information services which include investment and job placement information systems, tax and marketing information system, and maintenance of a public library:

WHEREAS, the both parties agree to the terms of partnership stated herein and cooperate in ensuring the necessary support and services are accessible and available to the *Pantawid Pamilyang Pilipino Program (4Ps)* beneficiaries and particularly those who are about to exit the program thus ensuring these families would still have the necessary support in cases of economic shocks and other vulnerabilities;

WHEREAS, a Memorandum of Understanding (MOU) is executed were terms and conditions stipulated upon to be acknowledge by the Parties for proper implementation of said program;

WHEREAS, the Local Chief Executive upon authorization of the Sangguniang Bayan may represent the municipality in all of its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made pursuant to law and ordinance;

NOW THEREFORE, for and in consideration of the above-mentioned premises and upon motion of Hon. Atty. Ana Marie V. Pagsibigan and duly seconded and unanimously approved by all members present in session assembled;

RESOLVED, as it is hereby resolved to approve this Resolution Authorizing Hon. Vergel C. Meneses, Municipal Mayor, To Enter And Sign Into A Memorandum Of Understanding (MOU) In Behalf Of The Municipal Government Of Bulakan With Regional Director Jonathan V. Dirain In Behalf Of The Department Of Social Welfare And Development – Field Office III (DSWD-FO III) For The Continued Implementation Of *Pantawid Pamilyang Pilipino Program (4ps) Act* For The Muninipality Of Bulakan;
