WHEREAS, letter from the Office of the Municipal Mayor dated September 8, 2022 has been received by the Office of the Sangguniang Bayan requesting for a resolution granting or authorizing the Local Chief Executive to enter and sign into a General Memorandum of Agreement with the Department of Social Welfare And Development – Field Office III (DSWD-FO III) for The Implementation of Poverty Reduction Programs and Social Protection Programs for The Muninipality of Bulakan;

WHEREAS, the local government have the mandate based on the (c), Section 22, Chapter 2 of Local Government Code of 1991 “*unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned...*”

WHEREAS, the Department of Social Welfare and Development (DSWD) is a government agency that envisions a society where the poor, vulnerable and disadvantaged individuals, families and communities are empowered for an improved quality of life and takes protection of the poor otherwise known as Social Protection;

WHEREAS, the Department of Social Welfare and Development (DSWD) adopts a “*Holistic Approach*” in ensuring convergence in implementation of various strategies, programs, projects and activities also known as Poverty Reduction Programs (PPAs) to address the needs of the poor;

WHEREAS, the Municipality of Bulakan is mandated by the Local Government Code (Republic Act No. 7160) to address the needs of its constituencies, and empower the people through direct participation in the affairs of the government, by allowing them to participate, decide on, initiate and innovate of development activities that address their identified needs;

WHEREAS, the Municipality of Bulakan is recognizes the role in ensuring inclusive development and commits to address the needs of the poor within its jurisdiction;

WHEREAS, a General Memorandum of Agreement is executed were terms and conditions stipulated upon to be acknowledge by the Parties for proper implementation of said program;

WHEREAS, the Local Chief Executive upon authorization of the Sangguniang Bayan may represent the municipality in all of its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made pursuant to law and ordinance;

NOW THEREFORE, for and in consideration of the above-mentioned premises and upon motion of Hon. Atty. Ana Marie V. Pagsibigan and duly seconded and unanimously approved by all members present in session assembled;

RESOLVED, as it is hereby resolved to approve this Resolution Authorizing Hon. Vergel C. Meneses, Municipal Mayor, To Enter And Sign Into A General Memorandum Of Agreement (MOA) In Behalf Of The Municipal Government Of Bulakan With Regional Director Jonathan V. Dirain In Behalf Of The Department Of Social Welfare And Development – Field Office III (DSWD-FO III) For The Implementation Of Poverty Reduction Programs And Social Protection Programs For The Muninipality Of Bulakan”


