# RECONSTITUTION OF MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF THE MUNICIPALITY OF BULAKAN, IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES

WHEREAS, Article 182 of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act 7160) mandates the creation of the Local Development Council;

**WHEREAS**, provides that each local government unit shall have a multi-sectoral development plan to be initiated by its Municipal Development Council (MDC) and approved by its Sanggunian;

**WHEREAS**, the Municipal Development Council shall assist the Sangguniang Bayan in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

**WHEREAS**, the recent local elections require reconstitution of the Municipal Development Council due to the end of term of office of former Municipal Development Council members; and

**WHEREAS**, based on the above premises, the Municipal Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the Municipal Development Council;

**NOW THEREFORE, I, VERGEL C. MENESES**, Municipal Mayor of the Municipality of Bulakan, by virtue of the power vested in me by law, do hereby order thereconstitution of the Municipal Development Council of the Municipality of Bulakan with the following stipulations:

SECTION 1. COMPOSITION OF THE MUNICIPAL DEVELOPMENT COUNCIL

# SECTION 2. DUTIES AND FUNCTIONS OF THE MUNICIPAL DEVELOPMENT

**COUNCIL** - The Municipal Development Council shall perform the following functions:

- A. Formulate long-term, medium-term and annual socio-economic development plans and policies;
- Formulate the medium-term and annual public investment programs;
- C. Appraise and prioritize socio-economic development programs and projects;
- D. Formulate local investment incentives to promote the inflow and direction of private investment capital;
- E. Coordinate, monitor and evaluate the implementation of development programs and projects.
- F. Perform such other functions as may be provided by law or competent authority.

SECTION 3. EXECUTIVE COMMITTEE - The Executive Committee of the Municipal Development Council is hereby created to represent it and act in its behalf when it is not in session. The composition of the executive committee shall be as follows:

## SECTION 7. DUTIES AND FUNCTION OF THE SECTORAL AND FUNCTIONAL

**COMMITTEES** - The members of the Municipal Development Council Sectoral and Functional Committee shall perform the following functions:

- A. Provide the Municipal Development Council with data information essential to the formulation of plans, programs and activities.
- B. Define sectoral or functional objectives, set targets and identify programs,
   projects and activities for the particular sector or functions;
- C. Collate and analyze information and statistics and conduct related studies;
- D. Conduct public hearings on vital issues affecting the sector or function;
- E. Coordinate planning, programming and implementation of program, projects and activities within each sector;

- F. Monitor and evaluate program and projects; and
- G. Perform such other functions as may be assigned by the Municipal Development Council.

# **SECTION 8. MEETINGS AND QUORUM**

- A. The Municipal Development Council shall meet at least every Friday of every other months of the year, or as often as may be necessary.
- B. A majority of the members of the council shall constitute a quorum. The affirmative vote of a majority of the members shall be necessary to approve plans, policies and program and project proposals.

#### **SECTION 9. BUDGET**

The Municipal Development Council Budget shall give priority to the following:

- A. Infrastructure project
- B. Economic Development
- C. Environment Development
- D. Social Development
- E. Institutional Development

#### **SECTION 10. COMPENSATION AND RENUMERATION**

The Co-Chairperson and members of the Municipal Development Council shall perform their duties as such without compensation or renumeration. Members thereof who are not government officials or employees shall be entitled to necessary travelling expenses and allowances chargeable against the funds of the Local Development Council, subject to existing accounting and auditing rules and regulations.

#### SECTION 11, TECHNICAL ASSISTANCE TO THE COUNCIL

All Provincial, City, Municipal Government Offices, Departments, Agencies are hereby enjoined to provide technical assistance, support and cooperation to the Municipal Development Council of Bulakan.

#### **SECTION 12. REPEALING CLAUSE**

All Executive orders or issuances inconsistent with the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

#### **SECTION 13. EFFECTIVITY**

This Executive Order shall take effect after its signing.
